## **SECTION 4. FIRST AID MEASURES**

#### Description of necessary first aid measures

**Eye contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check

for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. If a large number of containers are ruptured, treat as a bulk material spillage according to the instructions in the clean-up section. Do not touch or walk through spilled material. Shut off all ignition sources. No flares, smoking or flames in hazard area. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. #### Methods and materials for containment and cleaning up

Small spill:

### SECTION 7. HANDLING AND STORAGE

#### Precautions for safe handling

Protective measures:

#### SECTION 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Appropriate engineering controls:

Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapor or dust concentrations below any lower explosive limits. Use explosion-proof ventilation equipment.
