SECTION 5. FIRE-FIGHTING MEASURES

Special protective actions for fire-fighters:

Personal precautions, protective equipment and emergency procedures

SECTION 6. ACCIDENTAL RELEASE MEASURES

Large spill:

Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). SECTION 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Appropriate engineering controls:

Use only with adequate ventilation.
