Description of necessary first aid measures

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel:

In the case of aerosols being ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. SECTION 7. HANDLING AND STORAGE

Precautions for safe handling

Protective measures:

SECTION 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Appropriate engineering controls:

Use only with adequate ventilation.
