#### SECTION 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures

For non-emergency personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. #### **SECTION 7. HANDLING AND STORAGE**

#### Precautions for safe handling

Protective measures:
